GOOD INDICATIONS OF PROGRAM SATISFACTION ARE YOUTH STATING ON OUR ANNUAL SURVEY A 28% INCREASE IN OVERALL POSITIVE CLUB EXPERIENCE AND 24% INCREASE IN FEELING A SENSE OF FUN AND BELONGING. BGCHR'S FOCUS ON YOUTH MENTAL WELL-BEING WAS REFLECTED IN 86% FEELING EMOTIONALLY SAFE AT OUR CLUBS.
